Raws li ib qho ntawm txoj kev cog lus no, hauv District kuj yuav siv kev pab, online resources, uas tus tuav tej no tej zaum kuj yuav yog lwm pab neeg, thiab tsis yog tuav los ntawm District. Yog yuav cia cov menyuam siv tau tej kev pab, resources, muaj yam puav ntaub ntawv ntawm ib tug neeg xwsl – tus menyuam lub npe thiab chaw nyob email address – yuav tau qhia mus rau qhov chaw website company.

Tsoom fww muaj txoj cai thiab pab tiv thaiv tej lus zais tsis pub lam cia li qhia tej lus txog ntawm tus menyuam rau leej twg. Yog koj xaiv qhov tshem tawm li nram qab no, nws tsuas yog siv tau rau xyoo kawm ntawv 2023-2024 losis txog thaum hauv District taug qab hais tuaj txog daim ntawv, opt out form, seb qhov twg yog qhov tom qab (Cuaj Hlis 26, 2023 txog Cuaj Hlis 24, 2024).
